(THE LOAN [PART], WALLYFORD) (BUS, TAXI AND CYCLE GATE) TRAFFIC REGULATION ORDER 2023

TO – 479/23

East Lothian Council in exercise of the powers conferred on it by Sections 9 and 10 of the Road Traffic Regulation Act 1984 (hereafter the “1984 Act”), regulation 20B of the Local Authorities’ Traffic Orders (Procedure) (Scotland) Regulations 1999 and of all other enabling powers and after consultation with the Traffic Commissioner and the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order: -

1. This Order may be cited as the “East Lothian Council (The Loan [part], Wallyford) (Bus, taxi and cycle gate) Traffic Regulation Order 2023 and shall come into effect on 3rd January 2024.
2. The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under the 1984 Act or by or under any other enactment.
3. In this Order, except where the context requires otherwise:-
 - 3.1 “local bus” means a public service vehicle used in provision of a local service not being an excursion or tour;
 - 3.2 “pedal cycle” means a unicycle, bicycle, tricycle or cycle having four or more wheels, not being in any case mechanically propelled;
 - 3.3 “taxi” means a vehicle licenced under the Civic Government (Scotland) Act 1982; and
 - 3.4 “the Road” means the length of road in East Lothian specified in Schedule 1 annexed to this Order, which is at present a road.
4. The Road shall become an area with the right of passage being exercisable by local buses, taxis, pedal cycles only.
5. Where there is, immediately before the date on which the Road is redetermined under this Order, any apparatus belonging to any statutory undertakers, under, in, on, over or across the Road for the purpose of carrying on their undertaking, the said statutory undertakers shall after commencement of this Order continue to have all rights in respect of the said apparatus as they had immediately before that date.
6. Nothing in this Order shall apply to:-
 - a. Ambulance, fire brigade or police vehicles while in the performance of statutory duties;
 - b. To remove an obstruction; and
 - c. To avoid an accident.
