



## Proposal to Make the 20mph Speed Limit Permanent in Dunbar – South of the East Coast Mainline Railway



Sustaining Dunbar and East
Lothian Council want your views
on making the 20mph speed limit
permanent in some residential
streets in Dunbar. This leaflet
provides an update and includes a
questionnaire for you to complete.



East Lothian Council and Sustaining Dunbar are committed to making Dunbar a safer, more pleasant place to walk and cycle. As part of this work, we would like your views on the current 20mph speed limit trial on residential roads in your area, and whether it should be made permanent.

#### **An Update**

In October 2012, Sustaining Dunbar and East Lothian Council carried out a public consultation about proposals to introduce a 20mph speed limit trial in the residential areas of Dunbar, south of the East Coast Mainline Railway. An information leaflet and questionnaire were delivered to every household in the proposed trial area, seeking views. The results of the public consultation showed that:-

- 70% of respondents supported the introduction of a trial 20 mph speed limit;
- 68% of respondents thought that the introduction of a 20mph speed limit would make it safer to walk or cycle more.

As a result of general support for the proposal, in January 2014 East Lothian Council introduced a 20mph trial speed limit in the area shown on the map opposite. The trial is due to last until June 2015, and is the first of its kind in East Lothian. Initial results indicate that average traffic speeds have decreased on Kellie Road, Brodie Road, Middlemas Road and Lochend Road. A further three trials are due to commence in other parts of the County.

#### The Next Step


The 20mph speed limit trial has been in place for a year now and most people will have formed a view on whether it has been successful or not. This latest questionnaire gives you the opportunity to state your views on the trial and whether it should be made permanent or abandoned. The responses received will be reported to East Lothian Council, who will then

make a decision on whether to continue with the initiative or not. If survey results show

- a reduction in speeds,
- an increase in the number of people cycling, and
- majority support for the 20mph limit,

it will be made permanent when the trial ends in June 2015. If, however, most local respondents are not in favour, the 20mph speed limit will be removed once the trial ends.
