

## **East Lothian Council (Various roads, Dunbar) (Experimental 20mph Speed Limit) Order 2018**

**TO 091/18**

East Lothian Council in exercise of their powers under Sections 82, 83 and 84 and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by the Roads (Scotland) Act 1984 (which Act as so amended is hereinafter referred to as "the 1984 Act"), and of all other enabling powers and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:

### **Citation**

This Order may be cited as the "East Lothian Council (Various roads, Dunbar) (Experimental 20mph Speed Limit) Order 2018" and shall come into effect on the XXth day of [month] Two Thousand and Eighteen.

1. The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under the 1984 Act or by or under any other enactment.

### **Interpretation**

2. In this Order: -

- a. "Chief Constable" means Chief Constable of Police Scotland.
- b. "Vehicle" unless the context otherwise requires, means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether or not by mechanical power.

### **20mph Speed Limit**

3. No person shall drive any vehicle at a speed exceeding 20 miles per hour at any time on any of the lengths of road specified in Schedule 1 of this Order.
